A copy of the accounts for the year ended 31 December 2019 is included with these reports. They have been audited by Martin Sweet and on your behalf I would like to thank him for his time. With 10 years under our belts it can be seen that the Committee's objective to operate a club with low overheads is being achieved. By using electronic communications and utilising a free community bank account offered by HSBC our overheads are minimised.

When the club was established new members were asked to pay a joining fee to ensure that the club had sufficient funds to prepay booking fees or cover any unforeseen expenses which might be incurred when arranging events. As the membership grew and the yearly surpluses had added to the general funds it was decided to remove the requirement for new members to pay a joining fee. Now that the general funds held by the Club are sufficient to fund its operations the Committee has decided to give any member who paid a joining fee a subscription credit for 2020. This is reflected by the reduction in the Contingency Funds as shown in the accounts.

As in previous years I will be recommending to the Committee that the subscription remains at £5 per year.

As in 2018 we had eleven meets again last year. The November and February meets continue to attract the biggest numbers, showing the rugged nature of Murvi members. We had over thirty vans in Devon in November and eighteen in Devizes in February.

I am hopeful that there will be some Christmas meets again this year. Last year's were, once again, very successful.

When we get through the current lock down I'm looking forward to meeting up with lots of Murvis again, in the not too distant future.

At the first A.G.M. of the club there were 89 members, and each year we have seen a significant growth, reaching 300 at the 2019 A.G.M. However, this year we have only increased to 303, representing 543 people. 29 members resigned during the 12 months since the last A.G.M. 27 members have elected not to share their details with other members.

In the last 12 months the website has had 45,047 visits from 16,263 visitors.

At the 2019 A.G.M. the members indicated that they did not wish to proceed with a forum but were happy to continue with the chat group, which has had over 200 topics posted in the year. We have 68 people who have subscribed for automatic emails when a new item is listed for sale on the mart, 38 are not current Murvi owners.
