# **Brexit**

### **Driving Abroad and Green Cards**

With negotiations continuing over the United Kingdom's exit of the European Union and uncertainty surrounding the terms of the Brexit deal, we want to provide an update on the potential impact should the UK leave the EU without a withdrawal agreement. It is important to note that nothing has been formally agreed at this point but we feel you should be aware of the potential implications on the motor insurance industry.

Guidance from the Association of British Insurers (ABI) and Motor Insurance Bureau (MIB) is that drivers taking their motor vehicles into an EU country should be prepared and have a Green Card when driving abroad.

#### Why is a Green Card needed?

A Green Card is an international certificate of insurance which guarantees that the motorist has the necessary third party insurance cover. These certificates prove that drivers are suitably insured to drive in these countries. A physical copy of a Green Card on green paper is needed when traveling as digital copies are not currently accepted. If you arrive at the border without a physical Green Card, you may not be allowed to drive in that country.

There is also the risk that if you cannot supply the adequate proof of cover, your vehicle could get impounded in the country.

#### **International Driving Permits**

If the UK leaves the EU without a deal, you might need an International Driving Permit (IDP) to drive in all EU and EEA countries, apart from Ireland.

You will need:

1926 permit to drive in Liechtenstein

1949 permit to drive in Spain, Iceland, Malta and Cyprus

1968 permit to drive in all other EU countries, plus Norway and Switzerland

You can get an IDP over the counter at the Post Office.

They cost £5.50 and you must be a GB or Northern Ireland resident, have a full UK driving licence and be 18 or over.

#### What does it mean to you?

At present the majority of policies arranged allow for policyholders to drive within the European Union for a certain amount of time with the cover being confirmed by the insurance certificate we issue. However you are best to contact your insurers to confirm before travelling abroad.

## INSURANCE OFFICERS REPORT Ian Derbyshire

Our club Public Liability Insurance continues to prove extremely popular with our Member Clubs with nearly all now taking advantage of this excellent benefit.

If your club is one of the few that have not, then contact myself or Saffron Insurance and we will be happy to help. You do not want to run the risk of not having insurance; this puts your club and the committee at great risk and could leave you personally liable should anything happen.

I'm pleased to say that NIG have continued to offer the scheme to us this year. We have seen a small increase of 5% on the liability and 2.5% on the all risks scheme but this is the first increase for 4 years and still represents excellent value for money.

Renewals continue to be sent by email so please ensure you have received this and have dealt with the renewal. Please let myself or Saffron know if you have changed officers and have not received your invitation to renew.

No days of grace are granted with insurance and it is vital that your insurance is renewed on or before the 1st December 2020. Should you not renew on time, you will then have to arrange a new policy with Saffron and will still pay the full annual premium.

I would ask you give insurance the attention it warrants and deal with your insurance renewal promptly. It should not be for Saffron Insurance to have to start phoning and emailing, chasing clubs for payment.

#### NATIONAL PARKS AND EXTENDED RALLIES Peter Brown

We still have vacancies on the ACCEO Committee and currently do not have anyone to take on the Role of National Parks and Extended Rallies Officer. As well as continuing as Association Secretary, I will caretake this role until we have a volunteer to take it on.

There may well be rally application forms that contain the name and address of previous holders of the post so please do ignore that and email applications to nationalparks@acceo.org

#### **National Park Rallies**

Can I remind you that, as well as complying with the Caravan Sites and Control of Development Act 1960, all rallies that are planned within the boundary of any National Park must have the approval of the relevant Park. To process requests for approval, ACCEO must have applications for rallies in National Parks before the 1st of May of the year PRECEDING the rally. All of the applications we received for 2021 rallies have been approved. Any applications for 2022 must be received before 1 May 2021.

#### **Extended Rallies**

ACCEO Member Clubs who do not hold Paragraph 4 Exemption status are free (on request) to make use of the ACCEO Paragraph 4 Certificate with ACCEO making a tenancy agreement with the landowner and giving relevant notice to the local planning authority. These rallies can be up to 28 days in length. For this work to be completed, ACCEO must receive the Extended Rally application form at least 12 weeks before the date that the rally is planned to start.

# ACCEO Paragraph 6 rallies – Services to ACCEO Member Clubs

To potentially increase attendance at club rallies, ACCEO Member Clubs can use the ACCEO Paragraph 6 certificate instead of their own and open the rally to any member of any ACCEO Member Club.

Relevant Application Forms are in the Services area of the ACCEO website or available on request too.

#### 2. Convening the Meeting

The Chairman then asked the Association Secretary to convene the meeting.

#### Finance Officers Report for year ended 30th June 2020

There hasn't been much activity with our account since March but once again I am pleased to report that the Association remains in a healthy financial situation with the balance sheet showing a profit of £3,730.00.

Notes to the accounts

Income:-

Club Membership income is up on last year.

Commission income is significantly up because there were late payments received from the financial year 2018/19.

As I reported last year the 2018 National Rally made a profit of £1,604.00. We as a committee agreed to reduce the price of the 2019 Rally in an effort to attract more clubs/members to join us and to also run the rally closer to breaking even rather than a profit making exercise. The result of this was a £51.00 loss which we are well capable of carrying.

Expenditure:-

Committee & other meeting costs have lowered slightly mainly due to the fact that the committee have had no meeting and travel expenses since March.

The balance sheet still continues to show a healthy position and is able to cope with future requirements for the year 2020/2021.

Considering our financial position it is my recommendation that all membership fees continue at the present rates.

This makes it easier for the association to contact all clubs in an efficient, cost effective way. Once again I had a super response to renewals this year with a number of clubs opting to pay by BACs.

This year there have been 9 applications for National Parks Rallies for 2021, of these all have been approved except the Peak District I am still waiting for a reply, however a copy of there last email is attached


