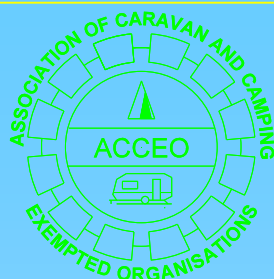

Insurance Matters

Our club public liability insurance continues to prove extremely popular with our member clubs with nearly all now taking advantage of this excellent benefit.

If your club is one of the few that have not, then contact myself or Saffron Insurance and we will be happy to help. You do not want to run the risk of not having insurance, as this puts your club and the committee at great risk and could leave you personally liable should anything happen.

I'm pleased to say that NIG have continued to offer the scheme to us this year and with no increase in premium, which is the second year running.

Renewals continue to be sent by email so please ensure you have received this and have dealt with it. Please let myself or Saffron know if you have changed officers and have not received your insurance invitation to renew.

No days of grace are granted with insurance and it is vital that your insurance is renewed on or before the 1st December 2018. Should you not renew on time, you will then have to arrange a new policy with Saffron and still pay the full annual premium.

I would ask you give insurance the attention it warrants and deal with it promptly. It should not be for Lesley at Saffron Insurance to have to start phoning and emailing you to chase you for payment.

Grove Insurance continue to have a caravan scheme which has some excellent prices for ACCEO members. Furthermore for every member that takes up that insurance, that member's club receives £5, or if you are an ACCEO Personal Member, the £5 goes to ACCEO.

I would ask all member clubs to promote this as it not only offers a service to your membership, but also puts some funds into your club.

The rally was held at the Ukrainian Youth Centre a sprawling enclosed area situated just south of Junction 3 of the A50, so it is within easy reach of the M1, M42 and the M6 and has hard flat ground suitable for caravans and motorhomes and space for over 200 units.

The centre has a large hall capable of seating our assembled throng with toilet facilities open 24/7 for those in need, and a bus service into Derby for those who wish to get out and see the countryside without driving.

As we are on the edge of a City you are able access all the facilities available and the majority are only a short hop away.

ACCEO have started a new way of setting up the National Rally. National Parks and Extended Rallies

National Parks

I am now taking applications from Member Clubs that wish to rally in any of the National Parks during 2020. Applications for 2020 must be with me by 24th April 2019 at the latest, so I have a chance to notify the relevant National Parks Liaison Officer prior to 1st May 2019 in order to have your rally sanctioned by the National Parks Committee. The earlier we get your application over to them the better chance you have of getting the rally approved. Please do carefully check where your rally is being held, the nearest town or village may be outside the National Park, but the site or village hall could be inside the park, so don't get caught out! As I announced at the recent AGM, all of the applications for National Parks rallies for 2019 were given the go-ahead.

Extended Rallies

Extended Rallies are for any rally you wish to run longer than 5 x 24 hours periods, and these can be applied for at any time. The only stipulation is that we need a minimum of 12 weeks notice. This is because we have to get a Tenancy Agreement set up between ACCEO and the site owner, after which we need to give the local Council's planning department 8 weeks notice of the rally taking place, and then get the copy exemption certificate back to you prior to the rally commencing.

Further details and application forms for both the National Parks and Extended Rallies can be found on the ACCEO Website.

Notes Taken at the Open Forum following the 35th AGM

held at the Ukrainian Youth Centre, Derbyshire

on Saturday 6th October 2018 at 2:45pm

The ACCEO Chairman, Chris Lowery, welcomed everyone back after the break. He asked if anyone had any questions for their Committee on matters of a more general nature than were able to be raised during the more formal proceedings of the AGM or if they had any other points they wished to bring up in this forum. He noted that attendance at the National Rally was quite a bit down again this year and asked members present if they had any ideas as to why this might be.

Firstly, Peter Brown (Association Secretary) dealt with a matter which was often raised. Can a Personal Member of ACCEO attend the AGM and vote? And if not, why not? The answer is they cannot, because ACCEO treats all Member Clubs equally and so the constitution allows for each Member Club to be represented at the AGM by one voting delegate. Gaynor Hart (Membership Officer) added that if all the members of a Member Club were Personal Members, that Club's views could be over-represented at the AGM.

Paul McCardle (Elddis Owners Club) commented that last year we adopted the accounts before they (the corrected version) had been published (this being done in a subsequent AM and by an email being sent round all Member Clubs). The Chairman noted the point and said we would take that observation on board for future years.

Paul McCardle (Elddis Owners Club) asked if it was permitted that a person with 2 cards can vote with both at the AGM. The Association Secretary said if they were representing 2 Clubs at the AGM, they could vote on behalf of each, as they were accountable to both Clubs for representing their views on any matter put to the vote.

Andy Napton (Omaha Camping & Caravan Club) asked whether under GDPR you should put names and addresses in the rallying booklet. The Association Secretary advised that you should only hold and publish such information that the Club needs in order to be able to conduct its business. (This will have been set out in your Legitimate Interests Assessment and communicated to your members in your Club Privacy Notice). If you need club members to be able to contact a Rally Marshal, then there must be the means of doing that, whether through a club website or at a home address – whatever is your usual practice. Names and 'phone numbers would be fine.

Phil Belt (Elddis Owners Club) asked how many members of a Member Club can sit on the ACCEO Committee. The Association Secretary advised that it used to be just one, but was changed to two at the 2011 AGM.

Roger Williams (Historic Caravan Club) wished to convey his thanks to the ACCEO Committee for all the hard work they do on behalf of Member Clubs, much of it behind the scenes. In particular he wanted to thank Peter Brown for all the research and subsequent excellent advice he put out to Member Clubs on GDPR. The forum concurred.

Maureen Ward (Swift Owners Club) asked if you needed National Parks permission to rally on a CS or CL in a National Park. Robin Wilkinson (the National Parks & Extended Rallies Officer) said you always need National Parks permission to rally in a National Park when you do this under the authority of your Exemption Certificate, and, as ever, he would be happy to process any application for this. The Association Secretary added that CL and CS owners were not adhering to their Para 5 licence rules by closing CLs and CSs for rallies. If the owners have a separate piece of land that can be used for rallies, that is fine, but you need National Parks permission to rally there in the usual way.

The Chairman took the opportunity to tell the Forum that responsibility for issuing Exemption Certificates had transferred from Natural England's Cambridge office to their Worcester office, and so all the paperwork would be emanating from there now. All clubs holding Exemption Certificates would receive a letter from the Cambridge office advising this.

John Haynes (Northern Ralliers Camping Club) asked if we could have the National Rally a bit further North in future. The Chairman replied that we try to keep it relatively central to make access easy for as many people as possible. The Association Secretary added that there used to be a tradition of Member Clubs offering to run the rally, whereby they could then suggest the venue. If any Member Club wished to continue this tradition, he would be very pleased to hear from them.

There being no more questions, or points raised, the Chairman declared the Forum closed at 3:00pm.

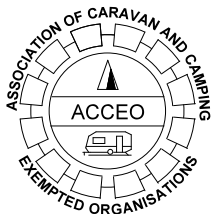

Playing Music at Club Events

If you perform or broadcast copyrighted music to your club members on premises that are not licensed to do so, you may wonder whether your club needs to purchase its own licence. The following information should help you decide.

Most (but not all) creators of music can claim copyright on their recordings for 50 years and that copyright is protected under UK law; the Copyright, Designs and Patents Act 1988.

Two independent companies were set up in the UK to recruit companies and performers on behalf of whom they would give permission for that artist's copyrighted works to be played in return for payment of a fee. Collection of the fees was facilitated by issue of a licence.

PPL represents record companies and performers for the use of recorded music, while PRS for Music represents songwriters, composers and music publishers for the use of musical compositions and lyrics (for both recorded music and live performances). They issue licences and collect royalties for certain uses of copyright-protected music, on behalf of their many thousands of members. They then distribute those royalties to members.

If your organisation played music to the public in circumstances that it was considered needed to be licensed then it would need licences from both organisations. In 2018, the two companies have come together to form PPL PRS Ltd and are moving towards issuing a combined licence "The Music Licence". The Music Licence allows you to legally play and perform music in your business, whether through the radio, TV, other devices and/or live performances.

If you play or perform music in your business or organisation in the UK, you will usually need The Music Licence. It will cover you, with one licence and one invoice, for the use of virtually all commercially released music available – millions of songs and recordings, including the most popular and well-loved music, not just from the UK, but also from around the world.

There is a PRS licence that was specifically developed for the Caravan Club and, in my opinion, is not relevant to ACCEO Member Clubs as we/you do not have comparable offices, fixed sites or frequency of events:

"This licensing agreement arises from rates (wef 6 March 2001) agreed with The Caravan Club Limited in regard to the use of our music (howsoever performed) at Caravan Club Centre rallies (including its annual National Rally) at locations and venues not otherwise covered by a Music Licence, and at Caravan Club owned sites (administrative offices and the like). It supersedes rates formerly listed in section 3.3 of Tariff HCP 2000.03 edition. It can also be applied to other caravan, and/or motorcaravan and/or camping organisations' rallies, but not to festivals of music and events for which PRS for Music operates specific tariffs (notably Tariffs APS, LP, LC, SE and X)."

The Caravan and Motorhome Club (as it is now called) pays a fee for each centre, site etc and it is very expensive.

I can't find any definition on the PPL PRS website (<https://pplprs.co.uk/>) that aligns with the playing of music for a small club's rally. It is not a legal requirement that a licence is obtained but if an individual copyright holder gained evidence that you had been using his copyrighted material without permission, then he could instigate civil court proceedings against you.

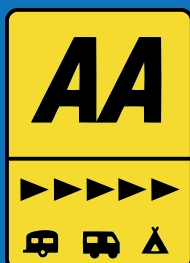
