Alan E King-Chair of ACCEO 1995 - 1999

Alan and his wife, Sheila were keen caravanners, travelling the length and breadth of the UK and abroad for many years until the sort of changes that the years bring compelled retirement from what was as much a way of life as an interest. They became members from early days of the Avondale Caravan Owners Club (ACOC) founded in 1972, and took a wider interest in a hobby that was being taken up by more and more people as caravan manufacture developed from a hand-built to a production-line process that made them available to a larger market.

His involvement with ACCEO stemmed from that interest. As an organisation, it did not exist until the amalgamation in 1985 of two other organisations, the National Federation of Caravan Owners Club (NFOCC) founded in 1968,and the Confederation of Caravan and Camping Clubs (4C's). The ACOC joined NFOCC and as a member of the ACOC Committee, Alan was one of their delegates to NFOCC. The increasing numbers of caravans and camping and caravan clubs holding rallies in the countryside and National Parks under the Exemption Certificates system led to the Dept of the Environment taking a closer interest in what was happening and sending out a consultation document to certificate holding organisations in 1978. Alan became more and more supportive of the negotiations between the parallel bodies, NFOCC and 4C's, that led to the formation of ACCEO following the winding up of both in 1985. It was during these developments that Alan met Bob Smylie MBE who became a good friend. Bob became ACCEO's first Chair and in 1994, its first President. He received the MBE in 1993 for services to the touring caravanning movement.

Alan continued his role as ACOC delegate to ACCEO's AGM, and he and Sheila were always strong supporters of the National Rally that was held over the May Day weekend at different venues every year from 1986 until 1999. The AGM rally was attended by club delegates only, but was opened to all members as the National Rally after 1999. Alan joined the ACCEO Committee as Newsletter Editor of 'THE BROADSHEET' and contributed to all the discussions generated by the queries from the membership, quite often about the exact interpretation of the legislation. He was a tireless worker on committee, using 'ACCEO MATTERS' as it became, to inform and entertain. He became Vice-Chair in 1994 and Chair in 1995.He encouraged the formation of a committee with the skills and commitment needed to take the Association forward. With the support of an insurance broker, ACCEO was able to offer caravan insurance to individuals in Member Clubs and public liability insurance on good terms to clubs in 1994. This generated enough income to support a part-time employee and office, but sadly, the broker withdrew support in 1999, causing the closure of the caravan insurance and the office with employee, but public liability insurance for clubs continues on good terms. He led the negotiations that enabled ACCEO to have a continuing presence at NEC Caravan shows, initially at the sole show in February, and now in October as well. He left office at the 1999 AGM knowing that ACCEO was now an established part of the rallying scene with around 200 Member Clubs and was recognised by national and local government as the representative body of the independent rallying clubs.

Sadly his final years were blighted by dementia and he passed away in August 2018 but he will be remembered by all who caravanned with him and his dear wife, Sheila in the ACOC and elsewhere, shared working on committee with him, knew him as a trustee of a Bus Museum, as a business man, listened to the hilarious antics of his Black Country friends, Enoch and Eli, and was never short of ideas. He will be sadly missed, but it was a life well lived.

Flat Batteries in Motorhomes using the Sargent EC500 Electrical System

Over the last fifteen years or so, the electronic systems of the chassis used for a panel van conversion or as the base for a coachbuilt motorhome consume energy from the vehicle starter battery constantly even when the vehicle is in storage. The chassis manufacturers all advise that the starter battery should be disconnected if the vehicle is not to be used for 2 weeks or more. In the last couple of years, Peugeot have fitted a facility that allows disconnection by selecting a position on the ignition switch.

Many of the specialist caravan/motorhome insurers require, as a condition of insurance, that additional Alarm/ Immobiliser and Tracker are installed. These draw additional energy from the starter battery such that it will only last a week or so in storage before the battery becomes fully discharged.

The addition of a large solar panel witheither a dual channel solar controller or single channel controller and battery mate can supply all the energy needed to keep both the starter and the leisure batteries fully charged during outside storage all year round.

Many UK motorhome manufacturers however use electrical systems sourced from Sargent Electrical Services and between 2014 and 2018 this was the Sargent EC500. The EC500 includes a bespoke 'Smart Charge' facility that is enabled as part of the standard system configuration. The Smart Charge feature will default to the leisure battery and will monitor the vehicle battery, if the vehicle battery drops below 12.4V the charger will divert the charge to the vehicle battery for a 4 hour period before returning to the leisure battery for 4 hours. At this point the system will default back to the leisure battery and monitor the vehicle battery.

This facility only works with the Power Supply Unit (PSU) switched on and is very effective on mains hook up or with charge from an 80W or larger solar panel for much of the year. However, when in winter storage, the energy consumed by the smart charge circuitry exceeds that gathered by the solar panel, the leisure battery that powers the PSU goes flat in a few days, and no solar generated energy reaches the vehicle starter battery so that flattens in a few days as well.

The Sargent guidance is therefore to switch off the PSU when the vehicle is in storage. Any solar energy gathered during that period is directed to the leisure battery and that is maintained in a good condition. Unless the chassis manufacturer's advice to disconnect the starter battery is followed, that battery will be flat in a few days.

Disconnecting the starter battery will disable all chassis electrics including central locking, alarm(s), tracker, etc and some owners may be concerned about that. However if the battery is allowed to go flat they will be disabled anyway with the added irritation that the vehicle won't start when wanted. Owners that have let the batteries flatten under these circumstances often find that the battery becomes damaged and must be replaced.

Formal Documentation Required for Rallies

I received the following question from one of ACCEO's Member Clubs:

A Club rally was recently held at a National Trust property. Although we have used the site before, we were asked to produce a Public Liability Insurance Certificate, Traffic Management Plan, Entertainments Licence etc. Whilst we were able to satisfy the request, we have never been asked to produce these before.

Could ACCEO please advise what formal documentation and risk management plans, a club like ours should have for a rally, so that we can be prepared. Would it be possible to issue a guidance note to all member clubs, to clarify the position as happened with Unit siting and GDPR?

Because this is such a nebulous subject, I don't think it would work in a generic Information Sheet but you may be interested to read my response:

It is for your Club to determine what formal documentation (if any) is required in the context of running any rally, but as far as satisfying other interested parties is concerned, the following may help.

- For a rally on a licensed Caravan Site, no formal documentation is required.
- For a Paragraph 6 rally, it would be sensible for the Marshal/Steward to have on site copies of the Exemption Certificate, confirmation that Public Liability Insurance is in place and a list of attendees confirming they are all bonafide club members.
- For a Paragraph 4 rally, it would be sensible for the Marshal/Steward to have on site copies of the Exemption Certificate, confirmation that Public Liability Insurance is in place, copies of the Tenancy Agreement with the landowner and of the letter notifying the planning authority of the intent to hold the rally.

Individual landowners may require other conditions to be met before agreeing to let the land for the purpose of holding a rally. These conditions can vary even for the same event year on year as mood and personnel change.

Many landowners rent out their land to be used as a location for events (such as music festivals, fairs, showgrounds, etc.) To meet various points of legislation they have to ensure that Police, Fire and other authorities are notified and therefore ensure that traffic, alcohol, entertainment, gaming, etc. legislation is complied with. They may deal with that themselves or they may make it a requirement of the Event Organiser. With a large administrative organisation, the easiest path for the staff to follow is to categorise a caravan rally as just another event and require the Club to do the work.

One requirement may be for a risk assessment to be submitted. That will usually be a requirement of a local authority or large national organisation (such as the National Trust) but some sports clubs have been known to ask for one. A risk assessment is a systematic process of evaluating the potential risks that may be involved in a projected activity or undertaking but many organisations amplify that definition to focus more particularly on their specific requirement (eg. implementing a project, building works, employing staff, permitting access to land, etc.). If your club is asked to prepare a risk assessment, the first move would be to request the organisation's risk assessment template, and you can then complete that knowing you have covered all of the topics where they have a concern. If that option is not available to you and your Club has a comprehensive Code of Conduct covering the arranging and management of rallies, then you can 'top and tail' that and present it as a risk assessment. If neither of those two choices are available to you then I suggest you ask the landowner for sight of a risk assessment that they have been happy to accept and use it as a model.


